Senate Bill Purpose

"Establish curriculum and graduation requirements aimed at college readiness and completion in the State of Maryland.

Further, it is the goal of the State that at least 55% of Maryland adults age 25 to 64 will hold at least an associate's degree by the year 2025."

Cecil & CCPS Partnership Pre-Senate Bill 740 Practices

- Four years of mathematics in high school
- Testing in the junior year of high school
- Dual enrollment (on-site and embedded in STEM)
- Documented college degree plans on file
- College Bound scholarships for tuition
- Identify and communicate with "Near-Completers"
- MOU between college & CCPS for dual enrollment payment protocols
